Bishop Cotton Women's Christian Law College, affiliated to Karnataka State Law University Hubballi, Approved by Government of Karnataka, Recognised by Bar Council of India New Delhi, and established in 2002 by CSI TA Karnataka Central Diocese (Church of South India Trust Association) under the able guidance of the Bishop, Karnataka Central Diocese as the Chairman. In the year 2019, the college was recognised under the status of 12B and 2f of the UGC Act 1956. The College is a registered member of India Survey on Higher Education of Government of India

Embarking on a transformative journey in legal education, "Empowering Women Empowering India" a vision envisaged by Dr. Elizabeth Thomas, Former Principal of Bishop Cotton Women's Christian College, initiated an integrated 5year B.A.LL. B course. Bishop Cotton Women's Christian Law College was ceremoniously inaugurated on July



14, 2002. A watershed moment transpired on August 1, 2002, as the initial classes commenced for the batch, I year B.A., LL.B., under the adept leadership of Dr. A.P. Porkodi, who assumed the pivotal role of the First Principal and the college being affiliated to the Bangalore University.

Charting a course of expansion, commenced the 3-year LL. B course in the academic year 2007-08, same year the institution also laid the foundation stone for a new building on the

August 18, 2007, reflecting its vision for growth and enhancement. In January 2009 the new additional building was inaugurated.

In June 2009, all law colleges in Karnataka were brought under the umbrella of Karnataka State Law University, Hubbali, and therefore the affiliation shifted from Bangalore University to Karnataka State



Law University, Hubbali, signifying a strategic shift in its academic alignment.

In the academic year 2012-13, the college transitioned to B.B.A., LL. B (5 Years Course), diversifying its educational wing.

This Latin expression means "neither to the right nor to the left"-but on straight on, Prophet Moses commanded the Israelites not to deviate from the law of God with the same words (Joshua 23: 6). This moto was given by Dr. G U Pope to the Bishop Cotton School. The college has inherited the same motto through its parent institutions.

THE COLLEGE SHIELD AND CREST

The Emblem of the college is the Crest of Bishop Cotton of Calcutta. The Crest is divided vertically down the centre. The right of the shield is called the Dexter and the left the Sinister. At the left of the Crest are found the arm of Bishopric of Calcutta- the Bishop's Mitre (head-dress), the Bishop's staff and the open Bible. The right side of the Crest contains the arms of the ancient house of Combernere in England to which Bishop Cotton belonged. The white figures of '8' like shapes represent skeins of Cotton. The inverted 'V' is chevron which is supposed to represent the gable of a house which was usually granted to a family for distinguished service in a siege.

In keeping our Cultural heritage students are instilled with human values through various programmes conducted in Bishop Cotton Women's Christian Law College. Students are trained to work hard, stick to discipline, aim to achieve the highest and march on to conquer the whole world as good leaders. ABOUT THE COURSE

- **1.** The "The Karnataka State Law University's Regulations" governs the 5 year B.B.A., LL.B Integrated Degree Course and 3 years LL.B Degree Course.
- **2.** The duration of the B.B.A., LL. B course shall be five academic years consisting of TEN Semesters. After Pre— University/ Twelfth standard education, one can opt for a 5-year Law Course single mindedly like any other professional courses namely Medicine, Architecture and Engineering.
- **3.** The duration of the LL. B Course shall be three academic years consisting of SIX Semesters. After completing Degree course of any discipline one can join 3 years Law course
- **4.** Each Academic year shall be divided into two semesters.
- **5.** The course also provided practical training, the students of 5 yrs. integrated course are to complete 20 weeks of internship that is four weeks of internship for every year of their study. The 3yrs course shall complete 12 weeks of internship, that is four weeks for every year of their study. They are further trained, attending courts- witnessing and recording the stages of cases, attend Lok Adalat, witness client interview in the chamber visit, witness mediation process at mediation centers, and impart legal knowledge as paralegal volunteers to the various stake holders of the society.

INFRASTRUCTURE

The Bishop Cotton Women's Christian Law College boasts a well-rounded and conducive infrastructure, set within a picturesque and lush green campus that enhances the overall academic ambience. The institution is fortified with a state-of-the-art library, providing a comprehensive repository of legal literature and e-library. An expansive auditorium accommodates various events, fostering a space for academic discussions and extracurricular activities. The college has adopted 5 villages in the Anekal Taluk with the goal of making them litigation free.

The objective of the unit is to provide community services by conducting various activities through awareness programs with the of aim to fulfilling sustainable goals. The Unit adopts a village every year and conducts services. Every year a special camp is conducted at the adopted village for seven days, where the NSS volunteers along with the program officer provide their community services.
